As of January 1, 2023 the EMS has turned over its accounts and a balance sheet was presented. Also, the EMS Board added 2 ESD board members to the accounts.

Commissioner Barker makes a motion to approve December 2022 financial report. Commissioner Mathews seconded, the motion carries.

# 6. Consideration, discussion, and any approval of FY2022-23 <u>Budget Adjustments</u> (Action Item)

#### • Blackjack adjustment for \$429.60

Blackjack requested an adjustment of \$429.60 from Emergency Services Equipment to Mechanical Supplies/Tools but should be \$431.42.

The Board requested a change to adjustment to cover overage.

Commissioner Mathews makes a motion to approve Blackjack adjustment of \$476.38 which includes the necessary increase. Commissioner Henry seconded, the motion carries.

#### • Seale adjustment for \$200.00

Seale requested an adjustment of \$200 from Dues/Memberships to Mechanical Supplies/Tool.

Commissioner Mathews makes a motion to approve Seale adjustment of \$200. Commissioner Henry seconded, the motion carries.

# Wheelock adjustment for \$103.06

Wheelock requested adjustment of \$103.06 from Building Maintenance to Other Gear.

Commissioner Barker makes a motion to approve Wheelock adjustment of \$103.06. Commissioner Mathews seconded, the motion carries.

# 7. Consideration, discussion, and any approval of Requests for <u>Preapproval</u> of Expenditures of Volunteer Fire Departments (Action Item)

 Blackjack preapproval for face masks, workbench brace/casters/wood and USPS Box fee items totaling \$1269.78

Blackjack is requesting approval to purchase 2 face masks for \$844, a workbench and lumber to make permanent for \$351.78, and annual fee of \$74 for post office box. Commissioner Barker asked why a box when there was a mailbox and the reply was because of the neighbors and thefts. Blackjack is compliant.

Commissioner Henry makes a motion to approve Blackjack to purchase items list above totaling \$1269.78 plus shipping. Commissioner Barker seconded, the motion carries.

## • Calvert preapproval for computer and accessories totaling \$1,389.96

Calvert is requesting approval to purchase a computer for \$1389.96. Office is not necessary because it is now a subscription.

Commissioner Henry makes a motion to approve Calvert to purchase computer totaling \$1389.96. Commissioner Barker seconded, the motion carries.

8. Consideration, discussion and any Approval of <u>Appropriate Expenditures</u> for Volunteer Fire Departments, payment of approved expenditures for FY 2022-23 expenditures (Action Item)

All departments are compliant except Wheelock. They did submit.

Commissioner Henry makes a motion to approve of Appropriate Expenditures for Volunteer Fire Departments and only Wheelock VFD fuel, payment of approved expenditures for FY 2022-23 expenditures. Commissioner Barker seconded, the motion carries.

Commissioner Mathews makes a motion to approve Payment of Robertson County Emergency Services District Monthly Expenses including payroll and Tower Expenses and Funds Transfer of \$369,000. Commissioner Barker seconded, the motion carries.

11. Consideration, discussion and any approval of Robertson County Emergency Services District approval of ESIP Presentation and Quote for Countywide Insurance Coverage (Action Item)

Seale asked if their building could be included in the county policy, but they pay the premiums. The answer is yes, it was confirmed by Kyle Yeary of ESIP Group. A request to add the Seale stations back in will be placed tomorrow. Executive Director was asked to hold VFIS and mail only if ESIP coverage was not completed by renewal date. An email will be sent to departments to review VIN errors.

Commissioner Mathews makes a motion to approve ESIP Quote for Countywide Insurance Coverage with updates to assets for \$128,427 and authorize president of the board to sign. Commissioner. Henry seconded, the motion carries.

12. Consideration, discussion and any approval of Letter received by Robertson County Emergency Services District Commissioner regarding safety concerns on fire scene (Action Item)

Following executive session, the Board directed Volunteer Fire Departments to review their contract for NIMS requirements/compliance and establishing command at scene.

- 13. Consideration, discussion and any approval of Robertson County Emergency Services District Subcommittee Recommendation for 2023 Employee Benefits package and items required for transition (Action Item)
  - Adopting an EMS Budget for the remainder of Fiscal Year 2022-2023
     The EMS contract ended on December 31, 2023. A 9-month budget was presented totaling \$2,800,855.48.
     Commissioner Yezak stated the EMS budget should be an extension of the Administrative Budget.

Commissioner Henry makes a motion to approve proposed 9-month budget totaling \$2,800,855.48. Commissioner Sanders seconded, the motion carries.

#### • First ESD-EMS payroll

The EMS contract ended 1 day prior to the end of the regular pay period. The Executive Director asked if the ESD could approve the extra day so employees would only receive one check instead of two, one from EMS, Inc. and one from ESD dba EMS. The Board said that was not a problem and adjustment could be made.

Bremond reported Tanker 4 is in production and will be ready in a month.

Franklin reported a delay in posting in the countywide paper for bids of truck but still intend on publishing request for bids. Buy Board trucks are a year out. Legal Counsel suggested contracting the COG (Brazos County Council of Governments)
